### ORDER:

In the Government Order first read above, the Government accorded approval for Master Plan for Coimbatore Local Planning Area under section 28 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government order third read above, orders were issued for declaring the inclusion of additional areas in the Coimbatore Local Planning Area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

3. In the letter fourth read above, the Director of Town and Country Planning has stated that the Master Plan for the modified Coimbatore Local Planning Area has been prepared, taking into consideration, the current developments and also future developments following the Urban and Regional Development Plans Formulation and Implementation (URDPFI) guidelines for preparation of Master Plans for Town and Cities. He has also stated that the essential components such as Mobility, Blue Green infrastructure, Economic planning and Land Use Plan as given in the para 3.8 of Supplementary Guidelines to the Scheme for Special

Assistance to States for Capital Investment 2023-24 Part III (Urban Planning Reforms) have been integrated in the Master Plan.

4. The Director of Town and Country Planning has requested the Government to give consent under sub-section (2) of section 24 of the said Act to the Coimbatore Local Planning Authority for the publication of a notice of the preparation of the Master Plan for the Coimbatore Local Planning Area.

5. Under sub-section (2) of section 24 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby gives his consent to the Coimbatore Local Planning Authority for the publication of a notice under section 26 of the said Act, for inviting objections and suggestions in the preparation of the Master Plan for the Coimbatore Local Planning Area.

6. The Draft Master Plan prepared for the Coimbatore Local Planning Area as consented by the Government under sub-section (2) of section 24 of the said Act is forwarded to the Director of Town and Country Planning, and he is requested to acknowledge the receipt of the same. The Director of Town and Country Planning is directed to ensure that the various requirements specified in the said Act and the Master Plan (Preparation, Publication and Sanction) Rules are strictly adhered to by the Coimbatore Local Planning Authority before the Master Plan is re-submitted to the Government for approval under section 28 of the said Act.
